Re: Expedited Process for Enrolling in Libertarian Party

Dear Voter,

This office is responsible for overseeing state and federal elections in Maine. Our records show that you were enrolled in the Libertarian Party of Maine (LPME) and that your enrollment in the party was terminated in 2018 when the Party became ineligible under state law to hold primary elections. The U.S. District Court, District of Maine, recently ruled in *Baines et al. v. Bellows*, 1:19-cv-00509-LEW, that your involuntary disenrollment from LPME was unlawful.

This letter is to offer you an expedited process to re-enroll in LPME should you choose to do so. If you wish to re-enroll in LPME, please sign and date the enclosed postage-paid postcard and place it in the mail. **Please return your postcard no later than Thursday, March 31, 2022.** If returning the postcard by this date presents a hardship, you may request an extension of this deadline to Tuesday, June 14, 2022, by checking the appropriate box on the postcard. Postcards received after Tuesday, June 14, 2022, will not be processed. If you do not return the postcard by the deadline, your current enrollment status will not be changed.

Even if you choose not to submit the enclosed postcard, you can always change your existing enrollment by completing a voter registration card and submitting it to your municipal office, the Bureau of Motor Vehicles, or any other agency authorized to accept voter registration cards.

Please note that if you are currently enrolled in another party, you will not be eligible to vote at any LPME caucus, convention or primary election for 15 days after submitting your enrollment card. Under the District Court's order, LPME is qualified to hold primary elections on Tuesday, June 14, 2022.
